Operating Hours

- **Course Availability:** Open Tuesday to Sunday, excluding Christmas Day and New Year's Day (late start at 10:00). Closed on Mondays, except for public holidays and during school holidays.
- The course may be closed for corporate events or due to weather conditions, as determined by club management.

Winter Hours (1 May - 31 August):

- Tuesday to Friday: 08:00 – Close
- Saturday & Sunday: 07:30 – Close

Summer Hours (1 September - 30 April):

- Tuesday to Friday: 07:30 – Close
- Saturday & Sunday: 07:00 – Close

Practice Range & Tee-off Times

Summer (1 September - 30 April):

- Tuesday to Friday: 07:30 – 15:00
- Saturday & Sunday: 07:00 – 15:00

Winter (1 May - 31 August):

- Tuesday to Friday: 08:00 – 15:00
- Saturday & Sunday: 07:30 – 15:00

Last Tee-off Times

- **9 Holes:** Latest tee-off at 15:00 (summer), 14:00 (winter)
- **18 Holes:** Latest tee-off at 13:00 daily

Please note: The Clarens Golf & Leisure Estate reserves the right to end hospitality services at the close of play.

After-Hours Access

Members wishing to access the course or practice range after the clubhouse has closed must make prior arrangements. Access will be granted upon presentation of an ID and an HNA handicap card at the entrance gate. After-hours access is restricted to the 'front nine' area, including the practice range and putting green. Access to the back nine is restricted after 17:00, and the tunnel gate will be locked at approximately 17:00.

Payment Options

To support our 2026/7 membership approach, Designed for Access. Defined by Quality., the Club offers the following payment options:

1. Full Payment (Once-Off)

Members may elect to pay the full membership amount upon receipt of the pro-forma or formal tax invoice. Once proof of payment has been received, all membership benefits will be activated immediately.

2. Split Payment Option (Deposit + Debit Order)

Members who do not settle the full amount upfront may make use of a split payment option, administered via our third-party debit order service provider, Netcash.

The terms are as follows:

- A 50% deposit of the total value of all items selected on the membership application form is payable upon receipt of the pro-forma invoice. (Inc. Total administration cost.)
- The remaining 50% balance will be collected via three (3) equal debit orders, processed through Netcash.
- A separate electronic or physical debit order mandate must be completed and signed in order to activate the split payment option.

Once the signed mandate and 50% deposit have been received, membership benefits will be activated.

Debit Order Administration Fees

- A R25 administration fee per debit order will apply.
- This fee will be included on the main membership invoice.
- Total administration cost: R75 (three debit orders).

Debit Order Dates

Members may select one of the following debit order dates:

- 1st of the month
- 15th of the month
- 27th of the month

Returned / Unsuccessful Debit Orders

- A R49 penalty fee will be charged for each unsuccessful or returned debit order.
- This penalty fee will be charged separately.

Should a debit order be unsuccessful:

- The member's account, including all membership benefits and HNA access, will remain frozen.
- The member may elect to settle the failed debit amount and the applicable penalty fee by:
 - EFT transfer, or
 - Payment in person at the Club.

If the member does not settle the failed debit amount and penalty fee independently, the Club will attempt to retrieve the outstanding amount on the next selected debit order date.

This debit will include the outstanding amount plus the penalty fee.

Please note:

While any debit amount remains outstanding, the member's account will remain frozen.

Membership Activation & Completion

- Under the split payment option, membership benefits remain active only while payments are up to date.
- Once the remaining 50% balance has been successfully recovered via the three debit orders, no further debit orders or charges will apply.

I recognize that The Clarens Golf and Leisure Estate's management reserves the right to close the course, suspend play, or request players to leave the course at any time due to weather conditions (such as rain or lightning) or any other reason deemed necessary by management.

I acknowledge that participation in golf and the use of the facilities, golf course, driving range, golf carts, and all related equipment at The Clarens Golf and Leisure Estate involve inherent and significant risks, including but not limited to serious personal injury, permanent disability, property damage, and death. These risks include, but are not limited to, being struck by golf balls, golf clubs, carts, or other equipment; collisions; slips and falls; uneven terrain; adverse weather conditions; wildlife; equipment malfunction; and the actions or omissions of other players, guests, contractors, or third parties.

I voluntarily assume all such risks and accept full responsibility for any loss, injury, damage, or expense arising from my use of the facilities.

To the fullest extent permitted by law, I hereby indemnify, release, and hold harmless The Clarens Golf and Leisure Estate, its owners, directors, officers, management, employees, contractors, and agents from any and all claims, demands, actions, losses, damages, liabilities, costs, and expenses of whatsoever nature arising out of or in connection with my use of the facilities, including claims arising from the ordinary negligence of the Estate or its representatives, but excluding liability resulting from gross negligence, recklessness, or intentional misconduct, where such exclusion is prohibited by law.
